I further agree to indemnify and hold harmless the Twin Oaks Valley Equestrian Association, Horse Heritage Conservancy, the City of San Marcos, its subdivisions, officers, agents or employees, sponsors and co-sponsors from all claim, damages, losses and expenses, including attorneys' fees caused in whole or in part by my negligent acts or omissions, unless caused by the gross negligence or willful misconduct of the Twin Oaks Valley Association, Horse Heritage Conservancy, the City of San Marcos, its subdivisions, officers, agents or employees, sponsors or co-sponsors.

The Horse Heritage Conservancy and Twin Oaks Valley Equestrian Association requires that **all riders** on horseback wear approved **safety helmets**. If you choose not to wear a safety helmet, then you as an adult rider will accept full responsibility for yourself for any injury that may result from the act when on horseback in this event. All riders on horseback under the age of 18 are required to wear a safety helmet when riding in this event.
